

NOTE: To qualify for a Texas Agricultural and Timber Exemption Registration number, you must be engaged in the commercial production of agricultural or timber products for sale in the regular course of business (for qualifying examples, see Item 18). Examples of the types of activities that **Do Not Qualify** for an exemption registration number include:

- home gardening;
- · horse racing, boarding or training;
- trail rides and zoos;
- florists or similar retailers who simply maintain plants prior to sale;
- · wildlife management and conservation;
- hunting and fishing operations, including aerial hunting;
- predator control and/or wildlife/livestock censuses or surveys;
- · commercial fishing; and
- · companion animal (pet) breeding and kennels.

The offense may range from a Class C misdemeanor to a felony of the second degree.
